General:

The following terms and conditions outline **More Than Just Dance DJ Services** responsibilities (herein also referred to as ours or we) and the Customer/Client s responsibilities (also herein referred to as you or yours .) This contract contains two parts; 1) **Terms and Conditions** and 2) **Event Information Form**, Please verify accuracy of the Event Information Form prior to affixing your signature below. **MTJDDJS** agrees to provide music and DJ services at the venue and as indicated on the accompanying **Information Form**.

The Venue:

MTJDDJS will normally arrive between 1 and 1 1/2 hours prior to the agreed upon start time to accomplish equipment setup and configuration. Most of the time, With just music equipment with can have our professional equipment up and running in 45 minutes. While **MTJDDJS** will work with the venue contact (to be provided by the client) to ensure a suitable working area, the Client is responsible for providing **MTJDDJS** with a 'reasonably' secure stage or floor area with easy (handicap accessible ramp or elevator) access. If there are two (2) flights or more of stairs, there will be an additional **\$75.00** charge added to the quoted standard rate. The Client is required to ensure that the DJ (Disk Jockey) operating location at the engagement venue is located within fifty (50) cable-feet of an AC outlet. If lights are included in the provided service, two independent 20 Amp outlets will be required to support the electrical current requirements of the equipment. If during the event the AC receptacles prove to be inadequate in supporting both the music/sound equipment and lights, the lights will be disconnected. The Client will **NOT** be entitled to a refund for the amount of the light rental in this case, nor will **MTJDDJS** be liable to refund any fees received or owed for temporary interruption to services due to inadequate AC power. **MTJDDJS** requires 2 6 foot tables and an 8 x 8 foot area for the equipment, as well as a 3 x 3-foot area for each of the speaker tripods on each side of the dance floor. If lights are requested as part of this contract, tripod areas must be 5 x 5-feet in size. Smoke machines are not used because it sets off the smoke alarm systems.

Safety:

In order to prevent liability resulting from accidental injury to any individual attending this performance, **MTJDDJS** reserves the right to deny any guest access to the sound system, CD s, cassettes, computers, and supplies owned or leased by **MTJDDJS**. In the event the DJ believes an unsafe situation exists, he/she may call upon the Client to remedy the situation. If no action is taken, the DJ may cease operation until the situation is resolved.

MTJDDJS will take reasonable safeguards to protect its equipment and music media. However, any damage or theft occurring to any equipment or music media owned or leased by **MTJDDJS** because of negligent acts of the Client or Client s guests will result in the Client being held responsible to pay for the damages or lost items. Typical damages may include alcohol spilled on Equipment or music, the kicking or knocking over of equipment or music, or theft of music media or equipment. **MTJDDJS** will notify the Client immediately upon discovery of an accident or loss.

Payment Terms and Contract Cancellation:

The Customer will make **payment at beginning of the engagement of this contract** by cash, or by check (ONLY LOCAL BANK) made payable to **GENE WILLMAN**. IF **MTJDDJS** does not receive the full payment by the event then equipment will stay loaded in truck until **cash** payment has been made. There will be an additional fee of **\$25.00** for returned checks.

You, the Client do hereby agree to pay the total contract amount (as shown on the front of this form) for the disc jockey and Entertainment services of **MTJDDJS**. Written cancellation of this agreement by the Client 30 calendar days or more in advance of the event will result in a full refund of any fees (including deposit) paid by the Client to **MTJDDJS**. Cancellation by the Client Within 30 days of the event will result in the non-refundable retention of the deposit by **MTJDDJS**, (though the deposit may be applied to a future booking if rescheduled). A deposit in the amount of **30%** of the total contract price, or **\$100** (whichever is more) will be required to hold, or book the event date with **MTJDDJS**, and is due at contract signing. In the (unlikely) event that **MTJDDJS** fails to provide and fulfill the services contracted herein, except for reasons other than death or acts of God, **MTJDDJS** will pay the Client two times the contracted amount as damages.

If overtime is anticipated, **MTJDDJS** will make every effort to accommodate the request. In the event of overtime, each fifteen minutes of **OVERTIME** will be billed at the standard quoted rate in 15-minute increments. Overtime is due before the performance in cash, in addition to the contracted amount. Before requesting that **MTJDDJS** participate in an overtime event, the Client must ensure that the venue coordinator has also approved the request.

By signing our signatures below, both parties (**MTJDDJS** and Client) agree to these contract terms and Conditions.
